Executive Summary

Archaeological monitoring of 43 slit trenches was undertaken between 18 May 2009 and 5 July 2009. These trenches were necessary to identify the location, size and level gradient of all existing utilities and associated features including underground culverts and basements. This investigation was carried out on behalf of the Railway Procurement Agency as part of the design and construction of the proposed Metro North light rail project. These slit trenches were situated at several locations across Dublin City Centre from the Mater Hospital/North Circular Road in the north, to St. Stephens Green in the south. A total of 13 slit trenches were located in close proximity to three National Monuments. Under Section 14 of the National Monuments (Amendment) Act 2004, these trenches required Ministerial Consent prior to excavation and included the Daniel O'Connell Monument (E3964), the William Smith O'Brien Monument (E3965) and St. Stephens Green Park (E3963). The remaining 29 slit trenches were excavated in accordance with the conditions of Section 26 of the National Monuments Act (as amended) and known as Metro North, Section MN107, Dublin City (08E956).

This report is concerned with the 29 trenches excavated to the north and south of the River Liffey. To the north of the city trenches were placed on the North Circular Road (ST 736 and ST 742), Leo Street (ST 739, ST 740, ST 741 and ST 743 A and B), Parnell Square East (ST 701, ST 702, ST 703, ST 704, ST 705, ST 706, ST707, ST708 and ST738) and O'Connell Street (ST781, ST 717, ST716, ST714 and ST713). Trenches to the south of the city were placed on D'Olier Street (ST 720 and ST 721), Westmoreland Street (ST 722, ST 723, ST 724, ST 725 and ST 726), and King Street South (ST 732).

Excavation of all 29 trenches resulted in the temporary removal of pavement and/or carriageway. The permanent surfaces were removed using a con-saw and jack hammer. Each trench was subsequently hand dug. Upon completion of archaeological and utility recording and survey, the trenches were backfilled and the appropriate surface reinstated.

Post-medieval deposits were identified within 11 trenches (ST 741, ST 713, ST 716, ST 717, ST 718, ST 720, ST 721, ST 722 ST 723, ST 726 and ST 732) .across the city. The majority of these were deemed not to be *in situ*. Red brick cellars were identified in four trenches (ST 708, ST 721, ST723, ST 726) and are most probably the basements of nearby upstanding buildings. A mortared surface was identified in ST 702 and a red brick coal chute in ST 703 on Parnell Square East. Again these are most probably related to the nearby buildings. A possible stone wall was identified in ST 716 on O'Connell Street and a metalled surface in ST721 on D'olier Street. All of the archaeological features and deposits encountered were post-medieval in date.

1. Introduction

This report presents the results of archaeological monitoring of 29 slit trenches located to the north and south of the City centre (Figure 1). Initially, the licence for the works was issuded to RPA Archaeologist Eimear Dennehy. This was later transferred to Tara Doyle of Headland Archaeology (Ireland) Ltd who is license eligible.

An archaeological excavation licence was issued in accordance with the conditions of Section 26 of the National Monuments Act (as amended).

2. Background

A total of 29 trenches were investigated on several well known streets north and south of Dublin City centre. The north side of the city included North Circular Road, Leo Street, Parnell Square East and O'Connell Street. To the south of the city trenches were opened on D'Oiler Street, Westmoreland Street, and South King Street.

The North Circular Road is an important thoroughfare on Dublin's northside. It was long considered the northern boundary of the city and still separates the city centre from the inner suburbs. It is also known for Pevsner architecture. The North Circular Road runs from the Phoenix Park in the west through Phibsboro, to North Wall in the east and is the location of a number of important institutions, The Mater Hospital and Mountjoy Prison are on the North Circular Road. Leo Street is a 19th century residential street directly to the west of North Circular Road. The street contains red brick terraced houses with small yards to the rear.

Parnell Square is a central square which is named after Charles Parnell, a 19th century advocate for Irish independence. This square is a significant Georgian square at the north end of O'Connell Street. Formerly named Rutland Square, it is surrounded on three sides by original intact Georgian terraced houses. Towards the north side of the square, one can see the Garden of Remembrance in which a memorial commemorates the Irish war victims who laid down their lives from 1919-1922. This garden opened in 1966 and was designed by architect Daithi Hanly. The square has been witness to numerous historic events.

O'Connell Street or Sráid Uí Chonaill is Dublin's main thoroughfare. It is one of Europe's widest streets and measures 49 m in width at its southern end, 46 m at the north, and is 500 m in length. O'Connell Street has its origins in a street named Drogheda Street dating from the 17th century. It was laid out by Henry Moore, Earl of Drogheda and was a third of the present width of O'Connell Street. It was located on the site of the modern eastern carriageway and extending from Parnell Street to the junction with Abbey Street. In the 1740s, a wealthy banker and property speculator by the name of Luke Gardiner acquired the upper part of Drogheda Street extending down to Henry Street as part of a much larger land deal. He demolished the western side of Drogheda Street creating an exclusive elongated residential square, thus establishing the scale of the modern-day thoroughfare. Gardiner also laid out a mall down the central section of the street, lined with low granite walls and obelisks topped with oil-fuelled lamp globes. It was planted with trees a few years later. He titled the new development 'Sackville Street' after the then Lord Lieutenant of Ireland, Lionel Cranfield Sackville, Duke of Dorset. It was also known as 'Sackville Mall', 'Gardiner's Mall' or simply 'The Mall'.

It was not until 1777 that the planning body in the city, the Wide Streets Commission, obtained a financial grant from Parliament and work could begin to realise Gardiner's plan.

For the next 10 years work progressed in demolishing myriad dwellings and other buildings, laying out the new roadway and building new terraces. Upon completion c. 1785-90, one of the finest streets in Europe had been created. The street became a commercial success upon the opening of Carlisle Bridge, designed by James Gandon, in 1793 for pedestrians and 1795 for all traffic.

During the 19th century further changes took place on Sackville Street, resulting in the gradual erosion of the unified classical street created by the Wide Streets Commission and its replacement with an ostentatious high-Victorian boulevard, comprised of elaborate individual buildings. One of the world's first purpose-built department stores was such a building: Delany's New Mart 'Monster Store' was built in time for the Dublin Exhibition of 1853 and was later purchased by the Clery family in the 1880s. It also housed the Imperial Hotel. Across the road, another elaborate hotel was built next to the GPO: the Hotel Metropole, in a high-French style. Similarly the Gresham Hotel opened in 1817 to the north of the street in adjoining Georgian townhouses and was later remodeled as it became more successful. By 1900 Sackville Street had become a well known shopping and business location and a highly successful city centre thoroughfare that had earned the title of 'Ireland's Main Street'.

The Easter Rising of 1916 led to the street's bombardment for a number of days by the gunboat *Helga* of the Royal Navy and several other artillery pieces which were brought up the Liffey to fire on the north of O'Connell Street. In 1924, Dublin Corporation renamed the street in honor of Daniel O'Connell, a nationalist leader of the early nineteenth century whose statue stands at the lower end of the street, facing O'Connell Bridge. The William Smith O'Brien Statue was designed and sculpted by Thomas Farrell. It was originally erected in 1870 and stood on an island at the O'Connell Bridge entrance to D' Olier Street, but it was later moved to O'Connell Street in 1929.

D'Oiler Street and Westmortland Street are broad streets whose northern ends meet at the southern end of O'Connell Bridge over the River Liffey. D'Oiler Street's southern end meets Fleet Street, Townsend Street, College Street and Pearse Street. It is named after Jeremiah D'Olier (1745-1817), a Huguenot goldsmith and a founder of the Bank of Ireland. D'Olier was the City Sheriff in 1788 and a member of the Wide Streets Commission. The street was one of the last major interventions in the Dublin city plan to be executed by the Wide Streets Commissioners. From 1895 to 2006 the Irish Times was based in D'Olier Street, leading the paper to be nicknamed *The Old Lady of D'Olier Street*. The paper is now based in Tara Street. In 1830, Samuel Lover was secretary of the Royal Hibernian Academy and lived at Number 9 D'Olier Street. Westmoreland Street is named after John Fane, 10th Earl of Westmorland, who was Lord Lieutenant of Ireland from 1789 to 1794.

The Gaiety Theatre is situated on South King Street. It opened on 27 November, 1871, with the Lord Lieutenant of Ireland as guest of honour. The theatre is known as the Grand Old Lady of South King Street and has remained a vital and ever changing expression of Irish culture and Irish society.

3. Objectives

The objectives of archaeologically monitoring the 29 trenches was to record and determine the character of any previously unknown archaeology within each trench and to recover artefacts according to the conditions stated with the issued archaeological licence (08E956). This involved monitoring the excavation of slit trenches necessary to identifying the location, size and level gradient of all existing sub-surface utilities and associated features.

4. Methods

Excavation of all 29 trenches resulted in the temporary removal of pavement and/or carriageway. The trenches were fenced off and a traffic/pedestrian management plan was set in place by GMC Ltd. The permanent surfaces were removed using a con-saw and jack hammer. Each trench was subsequently hand dug to a depth where utilities/archaeological features or deposits were encountered. The majority of post-medieval archaeological deposits were discovered not to be *in situ*, these deposits were hand dug and all artefacts present were recovered. Upon completion of archaeological and utility recording and survey, the trenches were backfilled and the appropriate surface immediately reinstated.

5. Results

As mentioned above, a total of 29 slit trenches were excavated in several locations across Dublin city centre. Each trench is described in detail below.

North Circular Road

Two trenches (ST 736 and ST 742) were located on the North Circular Road (Figure 2). ST 736 was orientated in a north-south direction and measured approximately 13 m long by 0.60 m wide and was 0.50 m -0.70 m deep. A second trench, ST 742 was situated to the immediate north of ST736. It was also orientated in a north-south direction and measured 3.50 m long by 0.90 m wide and was 0.50 m -0.80 m deep. Several utilities were identified within both ST 736 and ST742. No archaeological features or deposits were encountered.

Leo Street

A total of five trenches (ST 739, ST 740, ST 741, ST 743 A and ST 743 B) were situated on Leo Street. Three of these trenches were placed in the yards of two houses. The first house, Number 26, had one trench located in the backyard and one to the gable end of the house (Figure 3). The first trench, ST 741, measured 1.20 m long by 0.60 m wide, was 1.20 m deep and was orientated in an east-west direction (Plate 1). Under the modern surface was moderately compact medium brown silty clay with red brick, charcoal, mortar, rubble and oyster shell inclusions (023). Two post-medieval pottery sherds were recovered from this fill and included a creamware base sherd (08E956:023:001, Appendix 2) and a yellow patterned rim sherd (08E956:023:002, Appendix 2). Utilities were identified within this trench and no further archaeological features or deposits were encountered. The second trench, ST 740, was located at the gable end of Number 26. This was orientated in a east-west direction and measured 1.20 m long by 0.60 m wide and was 1.20 m deep. Several utilities were identified and no archaeological features or deposits were encountered. A third trench was situated in the backyard of a house to the north of Leo Street. ST 739 was orientated in a north-south direction. It measured 1.20 m long by 0.60 m wide and was 1.20 m deep. Several utilities were identified and no archaeological features or deposits were encountered.

Two trenches were located on Leo Street itself. ST 743A was situated on the pavement and carriageway to the north of Leo Street. It was orientated in an east-west direction, measuring approximately 6 m long by 0.60 m wide and was 0.50 m -0.70 m deep. ST 743 B was situated on the carriageway only and was located to the south of ST743A. It measured 5.75 m long by 0.60 m wide and was 0.50 m -0.70 m deep. Several utilities were identified in both trenches and no archaeological features or deposits were encountered.

Parnell Square East

A total of 9 trenches were excavated in this area and included ST 701, ST 702, ST 703, ST 704, ST 705, ST 706, ST 707, ST 708 and ST 738 (Figure 4).

ST 701 was located on the pavement to the north of Parnell Square East. It was orientated in a northeast-southwest direction and in total measured approximately 6 m long by 0.60 m wide and was 0.40 m -0.73 m deep. Several utilities were identified within this trench and included ESB, Eircom and water. No archaeological features or deposits were encountered.

ST 702 was situated to the immediate south of ST 701. It was orientated in a northwest-southeast direction and measured 2.30 m long by 0.40 m wide and was 0.80 m – 0.90 m deep. A lime mortared surface that was comprised of small worn flat slabs (001) was found under modern material at a depth of 0.90 m (Plate 2). It was situated in the centre of the trench and was approximately 2 m long. This surface was considered archaeological in nature and no further excavation was carried out. ST 703 was situated to the immediate southeast of ST 702 described above. It was orientated in a northeast-southwest direction and measured 2.20 m long by 0.60 m wide and was 0.60 m - 0.90 m deep. A post-medieval coal chute (002) was identified to the east of the trench (Plate 3). It was circular in shape and comprised of a red brick wall with a course of granite stone at the top. It measured 0.25 m in diameter and was located at a depth of 0.30 m from the surface. Several utilities were located further east and west of the coal chute. ST 704 was located further south of ST 703 on Parnell Square East. It was orientated in a northeast-southwest direction and measured 3.40 m long, by 0.60 m wide. It was excavated to a depth of 0.50 m. Several utilities were identified within this trench and no archaeological features were encountered.

Directly southeast of ST 704 was ST 738. It was orientated in a northeast-southwest direction and measured approximately 7 m long by 0.63 m wide and was 0.05 m – 1.05 m thick. Several utilities were identified within this trench and no archaeological features were encountered. ST 705 was located southeast of ST 704. It was orientated in a northeast-southwest direction and was situated on the carriageway only. It measured approximately 5 m long by 0.60 m wide and was 0.50 m deep. Several utilities were identified within this trench including gas. No archaeological features or deposits were encountered in this trench. Both ST 706 and ST 707 were located on the carriageway, southeast of ST 705. Both trenches were joined and formed an L-shaped in plan. ST 706 was orientated in a northwest-southeast direction and measured approximately 2 m long by 0.60 m wide and was 0.40 m - 0.50 m deep. ST 707 was orientated in a northeast-southwest direction and measured 3 m long by 0.60 m wide and was 0.40 m deep. A large pipe emerged from modern material in this trench. No archaeological features or deposits were encountered in either trench. ST 708 was located on the pavement and carriageway approximately 4 m southeast of L-shaped trench ST 706 and ST 707. It was linear in plan and orientated in a northeast-southwest direction. It measured approximately 6 m long by 0.65 m wide and was 0.40 m - 1.80 m deep. A red brick cellar (003) was identified on the pavement side of the trench. It arched slightly to the west. The exposed part of the cellar measured 0.60 m long by 0.60 m wide and it was identified at a depth of 0.80 m from

the surface. Utilities were identified to the east and west of the cellar and included ESB, Water, Eircom and unidentifiable pipes.

O'Connell Street

A total of five trenches (ST 713, ST 714, ST 716, ST 717 and ST 718) were excavated on O'Connell Street (Figure 5). ST 713 was located on the western pavement of O'Connell Street adjacent to Clarkes Shoeshop. It was linear in plan and orientated in a northeast-southwest direction. It measured approximately 9 m long by 0.60 m wide and was 0.40 m – 1 m deep. Several utilities were identified within this trench. Located to the east of this trench was moderately compact black brown silty clay (004) with rubble and red brick inclusions. It measured approximately 2 m long by 0.60 m with unknown thickness. The utility pipes lay directly over this deposit with no obvious truncations. ST 714 was located approximately 8.50 m southwest of ST 713 on the western pavement of O'Connell Street. It measured approximately 9 m long by 0.60 m wide and was 0.10 m deep. It was orientated in a northeast-southwest direction. A cement ceiling of a cellar was encountered for the entire length of the trench and no further excavation was conducted.

Slit trench ST 716 and ST 717 were joined and formed a T-shape in plan and were located approximately 18 m south of ST 712. ST 716 was linear in plan and measured 7.20 m long by 0.60 m wide and was 0.85 m deep. It was orientated in a northwest-southeast direction and was located at the southern junction with O'Connell Street and Abbey Street. A mortared stone wall/surface (006) was identified to the north of the trench (Plate 4). The stones appeared to be faced and measured approximately 0.70 m long by 0.60 m wide with an excavated depth of 0.35 m. It was possibly truncated to the south by ESB cables and to the east by a plastic pipe with sand bedding. A deposit of moderately compact dark brown black silty clay (007) with oyster shell, red brick and mortar inclusions was located directly north of the wall. It measured approximately 2 m long by 0.60 m wide with unknown thickness. A sherd of yellow glazed post-medieval pottery (08E956:007:001, Appendix 2) was recovered from this deposit. ST 717 was orientated in a northeast-southwest direction and measured approximately 8 m long by 0.60 m wide and 0.40 m -1 m deep. Several utilities were identified to the west of the trench. A deposit of moderately compact dark brown black silty clay (008) with oyster shell, red brick and mortar inclusions was located to the east of the trench. It was similar to the deposit found in ST 716 and it measured approximately 2 m long by 0.60 m wide with unknown thickness.

ST 718 was situated approximately 25 m south of ST 717. It was orientated in a northeast-southwest direction and measured approximately 6 m long by 0.60 m wide and was 0.30 m – 1.50 m deep. Several utilities were identified in this trench. A deposit of moderately compact dark brown black silty clay (009) with mortar and red brick inclusions was identified to the east of the trench. It was unclear if this deposit was *in situ* and none of the utilities truncated it. It measured approximately 1 m long by 0.60 m wide and was identified at a depth of approximately 1 m.

D'Olier Street

Two trenches, ST720 and ST721, were excavated on D'Olier Street (Figure 6). Initially archaeological deposits and a possible wall were encountered at a shallow depth in both trenches. The relationship between these deposits could not be ascertained when the trenches were first opened. Both trenches were reinstated and re-opened at a later date when all resources could be applied to determine the nature of the archaeology involved. Within ST 720 (Figure 7) the upper archaeological deposits and possible wall (011) were found not to be *in situ*. Excavation revealed a mixed deposit of moderately compact dark brown black silty

clay (012) with charcoal, stone and red brick inclusions (Plate 5). A total of 31 post-medieval pottery sherds (08E956:012:001-011, 08E956:014 and 017-035, Appendix 2), two ceramic tobacco pipe stems (08E956:012:015 and 016, Appendix 2) and two glass sherds (08E956:012:012 and 013, Appendix 2), possibly from an onion bottle were recovered from this fill. The deposit measured approximately 4 m long by 1.40 m wide and was dug to a depth of 1.20 m. An undisturbed metalled surface (013) was located to the eastern side of the trench. It was located at a depth of 0.56 m from the road surface and comprised of flat stones that on average measured between 0.10 m - 0.20 m in diameter (Plate 6). A ceramic tobacco pipe stem (08E956:013:001, Appendix 2) was recovered from the metalled surface.

Similar to ST 720, the upper archaeological deposits first identified within ST 721 (Figure 8) were also not *in situ*. A post-medieval deposit of moderately compact mixed dark brown black silty clay (016) with charcoal, stone and red brick inclusions was identified throughout the trench. It measured approximately 2.70 m long by 0.80 m wide with a known maximum depth of 1.50 m. A total of 14 post-medieval pottery sherds (08E956:016:001-014, Appendix 2) were recovered from this deposit. Animal bone (08E596:002-003, Appendix 3) was also identified and sampled. A red brick cellar (015) was located to the west of the trench. It had a known length of 3.85 m and was found at a depth of 0.90 m from the road surface. It consisted of red bricks bonded with a lime mortar (Plate 7). It remained unclear if the cobbled surfaces (010) and (014) located directly under the road surface were *in situ*. Similar to the trenches excavated on O'Connell Street, the post-medieval deposits encountered in trenches ST 720 and ST 721 may have been imported from elsewhere and used to level the ground prior to further construction works.

Westmoreland Street

ST 722 was situated on the eastern side of Westmoreland Street and incorporated both pavement and carriageway. It was linear in plan and orientated in an east-west direction. It measured approximately 8.50 m long by 0.60 m wide and was 0.25 m – 1.10 m deep. A deposit of moderately compact dark brown silty clay (017) with charcoal, red brick and stone inclusions was identified within this trench. It was not obviously disturbed and several utilities directly overlay it. Five post-medieval pottery sherds were recovered and included three creamware pottery sherds (08E956:017:002-003, 005), a black glazed red earthenware pottery sherd (08E956:017:001) and a sherd of blue and white transfer print ware (08E956:0017:004). ST 723 was located on the eastern side of Westmoreland Street directly south of ST 722. It measured approximately 10 m long by 0.60 m wide and was 0.30 m – 1.10 m deep. Similar to ST 722, utility pipes directly overlay an archaeological deposit (018). The ceiling of a cellar or wall (019) was also identified within this trench, approximately 1 m from the pavement surface and measured approximately 1 m in length by 0.60 m wide.

The remaining three trenches along Westmoreland Street were situated on the western pavement. The northernmost trench ST 724 was located on the corner with Ashton Quay. It was linear in plan and orientated in a north-south direction. It measured 6 m long by 0.60 m wide with a depth of 0.05 m – 1 m. Several utility pipes were identified within this trench and no archaeological features were encountered. ST 725 was located approximately 2.50 m southeast of ST 724. It was linear in plan and orientated in a north-south direction. It measured 6 m long by 0.60 m wide with a depth of 0.05 m – 0.25 m. A cement cellar ceiling was identified in this trench. It measured 5.50 m in length. Utility pipes were identified within the remaining 0.50 m of trench ST 725. No archaeological features or deposits were encountered. ST 726 was situated directly south of ST 725 on Westmoreland Street. It was orientated in an east-west direction and measured 3 m long by 0.60 m wide and was 0.05 m – 0.45 m deep. A red brick sloping cellar ceiling (020) was identified to the west of the trench

(Plate 8). It sloped from 0.30 m – 0.45 m from the pavement surface and measured 0.50 m long by 0.60 m wide. Directly over it was a deposit of loosely compact medium brown silty clay (021) with charcoal, stone and red brick inclusions. It measured approximately 1 m long by 0.60 m wide with unknown thickness. A total of eight post-medieval artefacts were recovered from this deposit. These included a sherd of black glazed red earthen ware (08E956:021:001), two shards of green glass (08E956:021:002, 007, Appendix 2), two stems from a ceramic tobacco pipe (08E956:021:003,008, Appendix 2), a sherd of brown glazed red earthen ware (08E956:021:004, Appendix 2) and two sherds of creamware pottery sherds (08E956:021:005-006). Animal bone (08E965:001, Appendix 3) was also recovered from this fill. Utilities were identified within the remainder of the trench at a depth of approximately 0.25 m.

The final trench, ST 732 was located further to the south on South King Street, at the junction with St. Stephens Green and Grafton Street (Figure 9). The trench was orientated in a northeast-southwest direction and measured 6 m long by 0.60 m wide and was 1.20 m deep. A post-medieval deposit of moderately compact medium brown silty clay (022) with charcoal and red brick inclusions was identified within this trench. The deposit measured 3 m long by 0.60 m wide with unknown depth. Two sherds of creamware pottery (08E956:022:001-002, Appendix 2) were recovered from this deposit.

6. Discussion

In general, with the exception of ST714 on O'Connell Street, all trenches contained a number of modern utilities. Post-medieval archaeological deposits were identified in ST 741, ST 713, ST 716, ST 717, ST 718, ST 720, ST 721, ST 722 ST 723, ST 726 and ST 732. Some utilities were located under disturbed post-medieval archaeological deposits. Many of the archaeological deposits investigated were deemed not to be *in situ*. In antiquity it is possible these rubble deposits were imported from elsewhere or were the rubble remains of older demolished buildings and were used to raise the surrounding ground level for further development. In recent modern times these deposits became further disturbed with the introduction of new utilities. Red brick cellars were identified in ST 708, ST 721, ST723, ST 726; these are most probably the basements of nearby upstanding buildings. A mortared surface was identified in ST 702 and a red brick coal chute in ST 703 on Parnell Square East. Again these are most probably related to the nearby buildings. A possible stone wall was identified in ST 716 on O'Connell Street and a metalled surface in ST721 on D'Olier Street. All of the archaeological features and deposits encountered were post-medieval in date.

7. Recommendations

Based on the results of archaeological monitoring in all of the locations described above, it is recommended that any further investigations to be carried out in Dublin City Centre be monitored by a qualified archaeologist under the terms and conditions set down by Department of the Environment, Heritage and Local Government.








Figure 1 - RPA Utilities Slit Trench Monitoring


















Figure 7 - RPA Utilities Slit Trench Monitoring: 08E956, Plan of slit trench 720.






Figure 8 - RPA Slit Trench Monitoring: 08E956, Plan of slit trench 721.
