Why are we doing this?

In the period 2007-2012...

9 Fatal Injuries

(5 Road Worker, 4 Construction Worker)

137 Major Injuries

(25 Road Worker, 112 Construction Worker)

Road worker	2,000	2	1 in 1,000
Road construction worker	15,000	1	1 in 15,000



Major roads, GB (31,233 network miles)	1,980 x 10 ⁸	1,168	1 in 11,000

- Road Worker Fatality 2/10/12




Accident Frequency Rate – 7 day RIDDOR










Alternative Entry Taper (9m spacing)



The hard-hitting DVD, which features scenes of near misses and accidents on the road network, is designed to make employees think about their personal behaviour and that of their colleagues, and to amend their working practices accordingly.

> Since 2009 Armey has undertaken a campaign to Target Zero Every Day' which aims for zero harm to its employees and the general public in the course of its operations. This has been coordinated with a significant. effort to introduce a cultural change across all its contracts and encourage employees to take responsibility for their safety, moving away from a "top-down" model.

The DVD forms part of this strategy. Its release complements the Highways Agency's faiming for



damage or injury. We have an excellent safety record at Arney, but we're not complacent and we're always looking for ways to reinforce messages on health and safety - that we all
