







## **Project Management Guidelines**

- Update to PMG's to publish Q1 2019
- Project Managers Manuals to publish Q1 2019
- Distinguish between roles of Sanctioning Authority & Sponsoring Agency
- Assurance from the Sponsoring Agency at the end of each phase
- Enhanced role for the Steering Committee at Phases 1 – 4 to guide the project




## **Cost Management Manual**

- General update required to incorporate into TII Publications
- To publish in Q1 2019
- Processes to remain generally similar
- Adjustment for compatibility with the 2017 Project Management Guidelines
  - Addition of Phase 0
  - Adjustment to Phases 3 & 4




## **Pavement Asset Repair & Renewal**

- Streamlined Process flowchart to reflect Sanctioning Authority and Sponsoring Agency roles
- 3 Gateways:
  - Approval of PARR
  - Award of Contract
  - Assurance of Project Delivery




## **Requirements for Measuring & Pricing**

- Re-introduction of BOQ to GCCC Contract
- Issues which have arisen
- Update to issue in Q4 2018 taking account of departures received
- No amendments permitted without an approved departure
- Departure application will need to give reasons for amendments
- Library of Standard Item Descriptions is available on the TII Publications website



## **Change Control**

- Changes proposed to the approval thresholds
- Objective of Changes
- In parallel IT based change control system under preparation
- Proposed roll out dates
  - TII managed Projects initially
  - Other Projects
